President Report: (Valentin)

- Valentin met with Knights of Columbus on the "Raise the Flag" fundraiser in Eagle Rock. Appetizers will be served and they are hoping for a good attendance.
- There was a discussion on who is responsible for the bridges in the WPOA on the county roads and Valentin said the county was responsible for their maintenance.
- Wild Park the WPOA will be starting to develop the Park
- Aqua Texas construction project, residents are asking when it will be complete and when the road will be resurfaced, Valentin reached out to Aqua and they said they will repave as soon as they can.

Treasurer Report: (Porterfield) Reported the budget looks good, They are projecting to be on budget and the increase in ACC fines has brought in additional income of over \$15,000 that originally projected. The office collected an additional \$7500.00 in past due fees since the last meeting.

Road Committee (Massey) Reported that he spoke to the road contractor who is willing to come out when he finishes his large projects and repair several more roads. There is approximately \$18,000 left in the road budget to cover the additional repairs.

Parks Committee (Potts)

• One of the plastic slides broke and a replacement was ordered. Potts and Porterfield will assemble the new slide once it arrives in September. Potts performed maintenance on the park equipment and talked about possibly replacing some of the aging equipment in the near future. The heat and use are showing signs of wear on several of the wooden structures.

- Peterson asked about needed improvements or replacements at Morrow Park and to use some of the remaining budget for this. Also to evaluate any larger purchases that may be needed for 2025 so the budget committee can include them for Parks.
- Peterson asked about having our mower begin cleaning up some sections of Wild Park, Parcel
 31, on the areas that border the main streets (Shady Bluff, Deer Ridge, and Woodacre). She will work with Potts to decide those areas.
- Potts again thanked Kurt Kimmerle for cleaning and care of the Dog Park everyday for the past five years. Kimmerle expressed concern about people smoking in the park in this dry weather.
