- **3.4.** Some property lines run to the street patching up to 2' on sides of streets to expand road a bit

4. ACC Committee (Eichelberger)

- 4.1. Last month slow
- 4.2. 1 house permit issued in January
- 4.3. 2 applications pending approval (need more information) in Shady Bluff
- 4.4. 4 fences approved
- 4.5. 2 storage structures approved
- 4.6. 2 decks approved
- **4.7.** Cindy back on ACC board she's good with deed restrictions she'll help with Red Tags (parking and storage violations)
- **4.8.** A homeowner contacted him about abandoned structures in Fallbrook: pump equipment left behind from a swimming pool/fountain. The homeowner asked if WPOA would fund/pay for removal. NO ACTION AT THIS POINT.

- **5.1.** He's walked and driven through the park a few times in the past month.
- **5.2.** Nothing visible appears ready to break. He reinforced some climbing equipment.

6.2. Wild Park (Parcel 31):

- **6.2.1.** 5-person committee met today to discuss vision and goals >> park or trail possibilities
- **6.2.2.** Step 1: any violations need to be Red Tagged
- 6.2.3. Step 2: Shady Bluff Ct segment can be easily cleared (Saturday, March 22)
- 6.2.4. Step 3: Gulf Crest and then walking trail (2025)
- **6.2.5.** Request to Board: \$\$ for picnic benches. ~\$350 each. There are some buckets to draw from in the budget already.
- **6.2.6.** Put out a notice to the neighborhood that it will be open soon.
 - **6.2.6.1.** Announce on Constant Contact
- **6.2.7.** Small library on property to make it more appealing.

 - 10.1. David Baker: president of non-profit Watershed Reserve. Woodcreek North has more impact on Jacob's Well and other water areas than other neighborhoods. Intervened in Aqua's rate increase charge case. We should see credit on the upcoming water bill due to overcharges (\$9M in refunds). September: Aqua is planning to raise rates again using different methodology. 6 miles of trails being mapped out (Karst Canyon Preserve). Losing ~\$2M/year that is going to Aqua. If the right plan could be put in place, then that money could be reinvested locally.
